Western Australians say price of water too low

7 October 2015: Authorities and other agencies increasingly understand that to best manage our water resources and deliver improved customer experience they need to hear what customers know, don't know and what their concerns are.

To support that, the Australian Water Association and Arup today released the 2015 Water Consumer Outlook, the results of a nation-wide survey to understand consumers' views about water in Australia.

The Chief Executive of the Australian Water Association, Jonathan McKeown, said that the majority of consumers nation-wide felt the price for water was about right or too low, however in West Australia, where the prices are amongst the highest in the country, 32% felt the price was too low (compared to 18% nationally).

"Only 24% of WA respondents described the price of water as too high, which is significantly less than the 38% nationally. Interestingly, 37% disagree that the price of water makes you careful about how much you use and 45% thought water should be priced higher so people use less – very different statistics to the other jurisdictions.

"At today's National Water Policy Summit we are discussing opportunities for the industry to come together and help the water sector shape a wider community campaign to value water as a major economic driver, as well as a national asset to be managed sustainably.

"The Survey gave us the opportunity to learn about what Australians understand of our water security and supply, so as an industry we can better engage with consumers so that their priorities and views are heard," Mr McKeown said.

Daniel Lambert, Arup's Australasia Water and Urban Renewal Leader supports an increased customer focus, "The water industry in Australia has recognised the importance of shifting from a compliance focus to a customer focus. This commitment has been reflected in the utilities statements of obligation which acknowledge the importance of their customers."

"In order to have a customer focus, it is critical for the water industry to understand their customers. The 2015 Water Consumer Outlook provides the results of a nation-wide survey. This report provides a valuable insight into customer's views on important issues facing the water sector." said Mr Lambert.
